

In the United States the right to petition is guaranteed by the First Amendment of the United States Constitution. The California Supreme Court in *City of Long Beach v. Bozek*, 31 Cal.3d 517, at 537 ruled. "It is essential to protect the ability of those who perceive themselves to be aggrieved by the activities of governmental authorities to seek redress through all the channels of government. A tort action against a municipality is but **one** of the available means of seeking redress." It is against this background that I seek redress of my workers comp settlement, signed in 2009 after being terrorized, harassed and coerced after being placed in a Program known as "Organized Gang Stalking."

I have lived in fear for the well being of my son and that of myself to this date. I decided to amass enough courage to address this letter to you; to detail what my son and I went through while I was disabled and as I attempted to return to work in 2008. I place my words on this paper as a testament of my ordeal. I request your office to investigate my claims, not just because you were the City Department that handled my workers comp. claim on behalf of the City, but also because you had taken an oath to uphold the Constitution of the United States and are tasked to uphold the laws of the State of California and the Rules and Regulations of the City and County of San Francisco. I ask this of you for what I endured was inhuman and cruel. It did not simply violate my constitutional right and that is, if I have any right, but also my human right as openly asserted under the UN Declaration of Human Rights. It is imperative that you, who sit at the helm of the City's legal apparatus, is aware of a Program known as "Organized Gang Stalking," i.e., if you are not aware of its existence. Such awareness will enable you to ensure that no City employee will ever be placed on this "Program" by any City employee, contractor or by proxy on your behalf. I have spoken to other City employees who had been placed on this 'Program', for one reason or other and who are still too afraid to come forth. They will, once their fear dissipates. Fear, intimidation, isolation, desperation, terror are the weapons utilized by the Program to ensure that its victims stay silent and voiceless.

I was encouraged to write this letter by the statement you made to the media as you launched a lawsuit against the Federal Government for its denial of federal funds so long as the City maintains its "Sanctuary City Status." You stated, "The president's" (Trump) "executive order is not only unconstitutional, it's un-American. That is why we must stand up and oppose it. We are a nation of immigrants and **a land of laws**. We must be the '**guardians of our democracy**' that President Obama urged us all to be in his farewell address." To this end, President Obama had also said "... Democracy can **buckle** when we give in to **fear**. So just as we, as citizens, must remain vigilant against external aggression, we must guard against a weakening of the values that make us

who we are..... **they cannot defeat America unless we betray our Constitution....** our democracy is threatened whenever we take it for granted..... Our Constitution is a remarkable, beautiful gift. But it's really just a piece of parchment. It has no power on its own. We, the people, give it power – with our participation, and the choices we make. It's the conviction that we are all created equal, endowed by our Creator with certain unalienable rights, among them life, liberty, and the pursuit of happiness. **It's the insistence that these rights, while self-evident, have never been self-executing;** that We, the People, through the instrument of our democracy, can form a more perfect union.” BARACK OBAMA

These are the words that gave me the courage to address this letter. These words that gave me self-worth; these words that gave me back my humanity which had been ripped off and peeled away like an onion, one layer at a time as I was placed on a 'Program' known as “Organized Gang Stalking.”

I am a former employee of the City and County of San Francisco, Port and later at MUNI. I was struck by a car, while on the job, in 2002. This accident placed me on the operation table, under multiple doctors. until 2008. In August of 2008, three weeks before my attempt to return to work at MUNI, I was made aware that I had been placed on a “Program” that I now know is “Organized Gang Stalking. It is my belief that I was placed on this 'Program' to deter my return to work as a disabled person and to ensure that I relinquish my right of due process in the settlement of my workers comp. case. I was terrorized, coerced, mobbed, forced out of the job and made to settle out of court for an injury that has left me disabled for the rest of my life. My name is **Senaite Shifferaw** and I am a Targeted Individual.

Some recipients of this letter have an idea as to what “Organized Gang Stalking” is and some might have taken part in its execution. Even those who participated in its application, in some form or another, might not be aware of the total component of the “Program”. I bring forth the analogy of a flower where each petal, attached to the center, acts independent of the other. The center that disseminates coded information determines their color and placement, These petals are further layered and compartmentalized and completely unaware of the existence of the others within each petal and that of the existence of the other petals that makes the flower whole. Each petal acts in accordance to the directive of the center. This is the point from which an activity or process is directed. This center is DHS/FBI/Fusion Center and the petals are the different institutions that are fused together and the water that keeps the root alive and the flower fresh is the fund that pours its way. This analogy will provide you and

other readers a reference point to understand the core of this complex program. I narrate my ordeal against this backdrop.

I will begin with an explanation of what comprises “Organized Gang Stalking.” According to **Fightgangstalking.com** and my own experience, “... OGS is the intense, long-term, unconstitutional surveillance and harassment of a person who has been designated as a target by someone associated with America’s security industry. Multiple groups form a single network would establish a single coordinated attack. The goal of such operations – in the parlance of counterintelligence agents – is “**disruption**” of the life of an individual deemed to be an enemy (or potential enemy) of clients or members of the security state.” The tactics used include – but are not limited to – “overt surveillance (stalking), slander, blacklisting, “mobbing” (intense, organized harassment in the workplace), “black bag jobs,” (entering home) abusive phone calls, computer hacking, framing, threats, blackmail, vandalism, “street theater” (staged physical and verbal interactions with minions of the people who orchestrate the stalking), harassment by noises, and other forms of bullying. In essence, organized stalking tactics could easily be exploited, and probably used as a weapon against individuals who have filed lawsuits to deter them from their due process rights. It could be initiated for any reason by someone who is either a member of the community, intelligence/security firms, law enforcement agencies, intelligence agencies, private investigators as well as FBI Joint Terrorism Task Force where the FBI has established alliance with local police departments nationwide. Similarly, being a member of the FBI-Corporate alliance called *InfraGard*, where most PI companies are members of, would create a perfect opportunity to have someone blacklisted and targeted. Someone with connections to current or former law enforcement or intelligence agency personnel – City Officials that are affiliated with Fusion Centers or military personnel with a background in intelligence – could mount a very serious campaign against a victim.

This “Program” can only stem from Fusion Centers that were organized under Homeland Security to avert terrorism in the Nation after 9/11. Fusion centers are staffed by local law enforcement and other local government employees as well as Department of Homeland Security personnel. DHS “has deployed over 90 personnel, including Intelligence Officers and Regional Directors, to the field.” In 2008, upon my return to work, there were DHS Personnel that were members of HR both at the Port and at MUNI. Fusion centers are often also co-located with FBI Joint Terrorism Task Forces which the City of San Francisco, after the participation of SFPD with FBI on this joint venture, has begun to distance itself from such collaboration as it believed further damage to civil liberties under the Trump Administration. CCSF was responsible to dispense federal funds to other cities like Berkeley and San Jose. Fusion Center is where Federal, State, City, County, Fortune 500 Companies, the military, Infragard as well as neighborhood associations come together to share information about

individuals who are deemed to be “threats” to any one of these member institutions. Nearly all private investigators are members of Infragard and have access to data through this membership..

In 2007, ACLU warned of the danger of Fusion Center to civil liberty. On its website it stated, “... again the federal government announced it was creating a new domestic intelligence agency made up of over 800,000 operatives dispersed throughout every American city and town, filing reports on even the most common everyday behaviors, while diverse and often still in the early stages of formation, they often seem to be characterized by ambiguous lines of authority, excessive secrecy, troubling private-sector and military participation, and an apparent bent toward suspicionless information collection and data mining. We urged policymakers to examine this incipient network of institutions closely and, at a minimum, to put rigorous safeguards in place to ensure that fusion centers would not become the means for another wave of such abuses.” .It continued,, “These centers can employ officials from federal, state and local law enforcement and homeland security agencies, as well as other state and local government entities, the federal intelligence community, the military and even private companies, to spy on Americans in virtually complete secrecy.” Other supporting and benefiting stakeholders include city and county administration, academia, information technology, and elected officials, attorneys, physicians, stores, entertainment facilities etc. After six months assessment, in 2008, ACLU warned again with these words : “In the six months since our report, new press accounts have borne out many of our warnings. In just that short time, news accounts have reported overzealous intelligence gathering, the expansion of uncontrolled access to data on innocent people, hostility to open government laws, abusive entanglements between security agencies and the private sector, and lax protections for personally identifiable information Overall, it is becoming increasingly clear that fusion centers are part of a new domestic intelligence apparatus. The elements of this nascent domestic surveillance system include: • Watching and recording the everyday activities of an ever-growing list of individuals • Channeling the flow of the resulting reports into a centralized security agency • Sifting through (“data mining”) these reports and databases identify individuals for closer scrutiny. Such a system, if allowed to permeate our society, would be nothing less than the creation of a total security state” As Fusion Centers have the power to collect, data mine and disseminate information to be shared by member institutions, the ACLU was also apprehensive as it found that these Centers had major flaws:-

**Ambiguous Lines of Authority.** Overlapping jurisdictions create the potential for manipulation of differing laws to evade accountability.

**Private Sector Participation.** Fusion centers are incorporating private corporations into the intelligence process, further threatening privacy.

**Military Participation.** Fusion centers are involving military personnel in law enforcement activities in troubling ways.

**Data Mining.** Federal fusion center guidelines encourage wholesale data collection and manipulation processes that threaten privacy.

**Excessive Secrecy.** Public oversight, individual redress and the very effectiveness of fusion centers are threatened by excessive secrecy.

I am not sure as to when my surveillance began nor did I have any illusion that I would not be placed under investigation for my claim as all Workers Comp claimants would be. The City has contracted with many PI's to conduct surveillance on their behalf. Of course, as many PI's are members of Infragard, I don't have any doubt that the ones that contracted with the City are members of this organization, which in turn grants access to Fusion Center data. Therefore, an individual placed on "Threat Assessment" under the Health Code and one who is attempting to return to work or could claim a 100% disability has to be discouraged from returning and need to be averted from going to court by any means necessary.

I was made aware that I was under surveillance in 2008. It began with my car, which was not driven all day, burned down in front of my home one afternoon. I did not connect it to my targeting at the time. Then weird events began to happen on my street. Individuals, color coded in black or red, claiming to be from different organizations began to knock on my door pretending to solicit my support for one thing or another. One incident I will never forget is a group of individuals, about ten of them, that began marching towards my home as I sat to smoke on my porch. They were all dressed in black suits, white shirt, black ties and dark glasses. They did not stop at any of the homes in the neighborhood. They targeted me and marched towards my home which sat in the middle of the 2600 Block of Mathews Street in Berkeley. They claimed to be from the Mormon Church. I thought they were FBI Agents and laughed at my own fears that stopped my heart for a moment. These types of weird incidents ensued. Cars parked in front of my home with individuals sitting in their cars for hours watching my home, my garbage searched and dumped, tricks exchanged, men lined up across my home relieving themselves, car alarm going off as I step out of my home, a 400 pound man, passing by in a small car with all four tires busted, a man walking up to my driveway and peeing as I watched him from my window, an 80 year old white women, bickering in front of my home, dressed in 'native american attire, which included the 'Chief's Headset' mocking the call of the POWWOW which in Native American culture is a call for "the seasonal celebration of life as well as for renewal of old friendships and form new ones" As indicated earlier, this is a sample of "street theatre" Then came the police. Every time I left my home there would be two to three officers following me and turning on their sirens, passing me by and turning it off. Then my neighbors, with whom I've lived for many years joined the bandwagon. I was followed around by many people I didn't even know, dressed in red shirts. I also began to be followed by black SUV's and black Jaguars which, in OGS is the synthesizing process. Finally, as I was being

amazed by these happenings, they entered my home. There was no sign of break-ins, but my furniture began to be moved around/ Items I had used the night before would be missing only to find them in my car. My clothes would be rearranged and moved from their regular places to another. They would be focused in underwears. Cutting, burning by cigarette in personal areas that would make one sick to the stomach. Drawers pulled, documents from my drawers that had any association with my job would be removed and placed on my dining room table; closed windows would be open upon my return home, etc. all to ensure that I know someone has been in my home. My Port issued ID, which I personally gave to my supervisor on the day that I was asked to move my stuff out from the Port, was brought back to my home and left on my dining table. They went after my medication....I would find them removed from their regular place and spilled out all over my home. My immigration papers, the doctor's report that I gave to the INS, which was sealed and one I did not even see, was brought to my home and placed on the table. Cessna helicopters began to fly low over my home and around places I visited. Threatening messages began to be left on my phone with claims of injury to my son. Soon thereafter, my son's teacher began to bike in front of my home, with a red cross backpack, without any acknowledgement to myself or the kid he claimed to instruct. Calls from the school with claims that my son was depressed added another layer of stress. Calls from his friends and other unknowns would insult me and hang up etc. This was followed by his backpack being dumped on the street and FB Account opened in his name with vulgar postings that was completely out of his character. This exposed him to be singled out and bullied at school. The fear I saw in his eyes haunt me to this day. He was only 13 years old and the cruelty of this Program is astounding. My gas burner, all four of them, will be turned on with the pilot off, allowing gas to fill my home. This was intended to blow us up in our own home. People I knew for many years began to stick their noses at me and pass me by. The non stop phone calls with the leading lady of this drama being Lisa Cortell, the RN that was the case manager of my case. Things that are spoken in my home would be repeated back to me by individuals I do not even know, in coffee shops and stores. This informed me that I was being listened to in my home 24/7. There were cameras or other high tech instruments flying overhead or placed on my home that viewed the internal space as my family, friends and myself were watched 24/7. . Some of my AC/DC plugs in my home were removed from their regular place and rewired at another space. This was done to manipulate my space with 'Lilly Waves' to influence my emotional state. Constant grinding of metal under my house depriving us of sleep. Sleep deprivation is one of the tools of the tools utilized by OGS. In a nutshell, OGS, is a systematic forum that manipulates the target's reality in an attempt to drive the target crazy. The organized way it was delivered and the institutions that took part in my attack could not come from anywhere but from a well funded and well oiled machine. My research informs me that

it is synonymous to a "STASI" type of program that reigned in East Germany before the fall of the Berlin wall. My research also informed me that Homeland Security was developed and the contract for its implementation was given to the former East Germany head of the Stasi, Markus Wolfe and former head of the KGB, General Yevgeni Primakov.

The one item that was left in my home, over and over again was the "STOP" sign. It would be clipped on my refrigerator, it would be left on my dining table, it would be left in my bedroom side table etc. Sure enough, on my first attempt to return to work at MUNI in August of 2008, I was placed in a cubicle that had a big "STOP" sign erected at its top. It was then and there that I made the connection as I sat for days on end in that cubicle equipped with only a phone. The mobbing and isolation I experienced at MUNI for the short period of time as I attempted to bring normalcy to my life was an amazing drama. The actions of other employees, their looks, as if disinformation about me had spread around, very clear. The STOP sign was a clear indication that I was not wanted and carried the message that I should "STOP" and return home. I persisted as my handbag was searched and took in the mistreatment of my so called supervisors. As I one of these days informed, Alice the supervisor I reported to at MUNI that I was going to break, I will never forget her reply "You could go and never return if I wish to do so." Puzzled I will sit and wait. Then the Supervisor. I think his name was Tom. would call me outside the cubicle surrounded by many other employees as he undressed me with claims that I was a couple of minutes late coming to work. He would state that my request for a doctor's appointment had to be reviewed as I did not have any leave accumulated...etc. Then the Personnel Director will place a huge chair in that small cubicle during my break time, would run in on my return and inform me that "You do not have any boss but HR and that HR and only HR will decide where you go and what you do." He would pick up his pen, place it close to my eyes as he claimed "HR would decide where you go once we crossed all the 't's and dotted all the 'i's'. I was shell shocked of all that was transpiring as I connected the incidents at MUNI with what was transpiring in my own community. My stalking continued on the streets of Berkeley as well as San Francisco as I would be crowded by individuals...on the left, right and behind me singing "America the Beautiful" all the way from BART to MUNI and back. I was terrorized and in disbelief. Yet there was no way I could bring logic to the incidents that was going on in my neighborhood, my home, the City I lived in, the City I worked at with what was going on at MUNI. It was the continuous threat to my son by people I did not even know, showing me guns as they passed me by in the street, leaving me messages as to what I should do to avert any damage to him that took a toll on me. I was finally placed at a job out at Cesar Chavez Street where I had to start work at 6:00 am. This meant that I had to wake up at 4:00 am to start to get ready for work. Soon as

the lights went on, there would be a motorbike that would roar past by my home each and everyday. The alarm that I set for my son to enable him to wake up at 7:00 am would be turned off. I could not continue with my work as the pain and stress affected me to such an extent that I was unable to get out of bed. Bottles of 60 mg Morphine (opioid) would be planted in my home labelled as if it was dispensed from my pain management physician. At a time when he had placed me on 30mg the appearance of these 60mg bottles were placed to frame me. I took the bottles to Dr. Jamasbi, my PM Physician. He looked at the labeling and looked kind of distributed. He informed me it did not come from his office. I then asked him if there was any way, by the number placed on the bottles, that I could check the origin of these bottles. He informed me that there was no way to find out. The fact that these bottles had his name on them and the casual way he took it in turn disturbed me as I took the bottles back. This is simply a sample of the incidents that transpired for I do not want to bore you with details of the attack I endured 24/7. After nine months of this never ending terror, I decided to close my case for the City was the only entity that I had any sort of legal wranglings. I closed my case, out of court, in the hope that this nightmare would end. All of what happened to me was narrated to my Attorney. The only thing she did was to make sure that I had psychiatry coverage in my settlement, as she gave up the injury that I sustained above the neck, She informed me that she never heard of this sort of harassment I was talking about. The only answer she had for me was that my garbage was not protected under privacy law, even if someone goes through it, while it is on private property. I had spoken to the Berkeley's Police Chief, personally in 2008. After listening to me he suggested that I will be better served if I saw a psychiatrist. I had talked to an ACLU agent who informed me that they had reports of such incidents from the muslim community and added that the FBI has a right to enter people's home without a warrant under the Patriot Act. He told me that there was nothing I could do about it, but, if anyone files a lawsuit against me using items that they retrieved from my home during one of these searches, ACLU will retain an attorney for me. I had called the Office of Barbara Lee. I had called my representative at Berkeley. I had called the office of Dianne Feinstein as well as that of Barbara Boxer. I had called the office of Nancy Pelosi. had also contacted SEIU. As a matter of fact, I had visited their office once to discuss this matter. Only to be turned away. I remained hopeless and suffered major depression with no place to turn but the ears of my family and friends.

The "Program" has many moving parts. As stated above, it is the alliance of many institutions organized in one network that made untangling all of these incidents ambiguous and impossible to pin down the source. The Program is delivered through a Network. The Network is made up of many isolated individuals and groups. Most large corporate workforces and many smaller ones have already been brought wholesale into

this Network through 'Occupational Health and Safety' laws that require employees and employers to report anything in the workplace that might be considered suspicious or threatening activity. Anyone who is reported on is assessed (without their knowledge) to determine if they should be put on a 'watch list'. Watch lists are a key aspect of the Network's operations. Maybe I was placed on a 'watch list' way back in 2003 when I came back to fight for my job after being fired six weeks into my accident. I had taken my claim to Port Commissioners, City Supervisors and had filed EEOC claim. Similar 'Community Health and Safety' laws have been established so that these reporting systems also extend into school environments, church congregations, social groups, neighborhoods and public streets, and even private homes. A special reporting system has also been set up to accommodate these laws and manage everything, and various types of recruitment programs which are routinely conducted within workplaces, community groups, and elsewhere, to enlist 'citizen agents' and to promote the security advantages that Network members receive. This includes receiving instant notifications by phone whenever a dangerous person is in their area. This notification service is only available to members who have signed a secrecy oath or non-disclosure agreement.

The many individuals and groups that make up the Network's vast and varied membership are kept as isolated as possible from other members and completely unaware of the full extent of the Network, and they don't know about or even expect that many of the other individuals and groups are involved, and identities between members are kept as anonymous as possible. However, some groups of members will necessarily be aware of each other's involvement to some capacity, but these groups remain otherwise just as anonymous and isolated within the Network. All information circulated through the Network is carefully controlled, and cover stories can be given for the activities that members engage in, as well as the pretexts for doing so. Some examples include members of Human Resource, Police Officers, Psychiatrists, Mental Health Professionals, Physicians, Attorneys. Senior members of the Department or Division Heads. In some cases there might be just a small team, who then liaison with various other departments. The team members are pre selected, so the team is already in place. The team should generally be trained in assessing workplace violence, violence on campus, what to do, who to call, and they might also be trained in profiling an individual, to enable them to make an assessment of whether an individual is a threat vs a non threat to the environment around. (Fightgangstalking.com)

The ACLU has continued to reach State and local governments about the dangers of Fusion Centers. In an article entitled "More About Fusion Centers," ACLU wrote, "In 2010 DHS Homeland Security Grant Program established a requirement that fusion centers certify that privacy and civil liberties protections are in place in order to use DHS grant funds. This is the first time DHS has acknowledged its authority to regulate fusion center activities and it coincides with the establishment of a new DHS Joint Fusion Center Program Management Office to oversee DHS s to fusion centers. While these

are only small steps, they are important advances toward establishing an effective governance and oversight structure over fusion centers. But reforms are not taking place fast enough and fusion centers and the risks they pose only continue to grow.” My targeting was in 2008 where the loose affiliation of institutions was in place.

Since the era of slavery, racial and ethnic minorities have disproportionately been victimized by false arrest, verbal abuse, harassment, and unjustified police violence. “Urban police forces long maintained political intelligence units (also known as AntiSubversive Squads, or Red Squads), which spied upon and sabotaged numerous peaceful groups—often in utterly illegal ways—throughout the twentieth century. For its part, the FBI ran a domestic intelligence/counterintelligence program called COINTELPRO ....The Senate panel that investigated COINTELPRO (the “Church Committee”) in the 1970s found that a combination of factors led law enforcers to become law breakers. But the crucial factor was their easy access to damaging personal information as a result of the unrestrained collection of domestic intelligence” (German & Stanley,2007).

Organized Gang Stalking is COINTELPRO 2.0 that utilizes sophisticated technology that strips away individual liberty in the name of security. It is executed covertly. It is important to remain aware that the goal of covert warfare is destruction of one who is deemed to be enemy of the state. Covert Warfare, as it is waged today, is highly organised and systematic. It is high tech lynching at best. It draws for its methods on the best outcome of research in psychology, the social sciences and state of the art war technologies most of which is classified. It utilizes results of research conducted on unsuspecting civilians, using the best of chemical and biological know-how to create states of mind and health within the victim that can be used to cause demise whereby the cause looks all too natural. Funding for this type of systemic harassment can only be authorised at the highest governmental levels.

What I had to endure was unconstitutional. It was against the laws of the land and ask your good office to investigate my claims and right the wrong. The City and County of San Francisco is government made up of progressive individuals that take the lead in the implementation of change. Maybe it lost its way in its effort to protect the national interest and security of the Republic. The Trump Administration has made matters worse. It had gone far beyond of what the immigrant community had to endure since 9/11. The safety of the citizens of this nation depends on legal minds like yours who would ensure that the Constitution is not violated, in your name. and the rule of law is in place to serve all. Safety at the cost of our civil liberty and at the cost of our Constitution is only an illusion that would destroy us from within. Targeted individuals are forced to live in a Panopticon metaphorical prison, the feeling that you are always watched by entities you cannot see or touch.

Organized Gang Stalking is disseminated throughout the nation. Targets have taken to the internet to inform others of its existence, as unbelievable as it may seem.

Organized Gang Stalking means attack by Directed Energy Weapons where frequency is used on our state of minds. You would find over 6 million postings on google and I believe it was such postings that forced the NY Times to address and disseminate disinformation to their readers on an issue in 2016 entitled "United States of Paranoia: They See Gang Stalkers." Kindly read this article and you would have a general understanding of the "Program" known as "Organized Gang Stalking".

I conclude by stating these sayings

““When the rule of law does not apply, and when Constitutional Rights can be violated at whim, you get amorphous mass rather than some pristine rule of law procedure that you can point to and say, this is a wholesome government.” UNKNOWN

It was Pope John II who said, “When freedom does not have a purpose, when it does not wish to know anything about the rule of law engraved in the hearts of men and women, when it does not listen to the voice of conscience, it turns against humanity and society.”

I hope this letter will give you the incentive to look into the role of the Fusion Center in your City as well as into the settlement of my workers comp case. You will find, hidden in plain view, reports that would unravel my claim.
